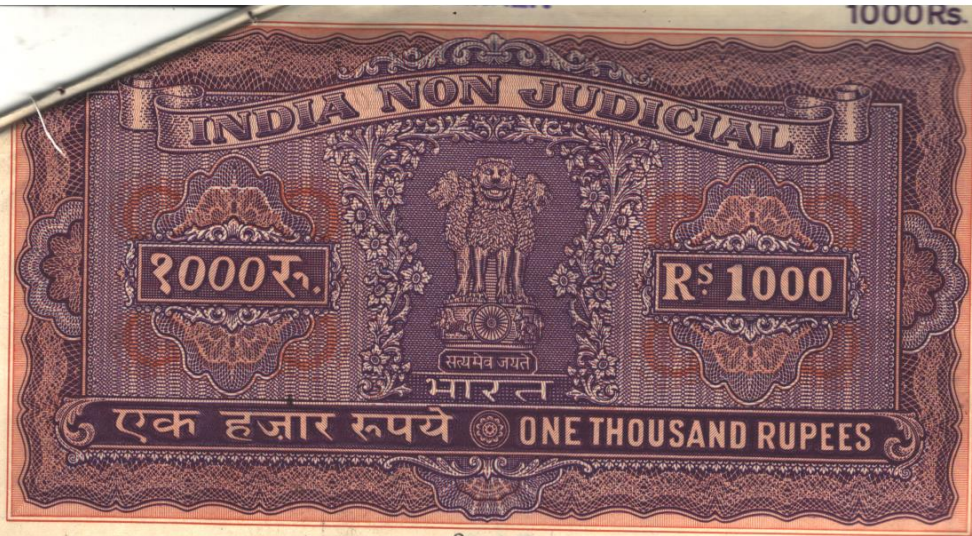

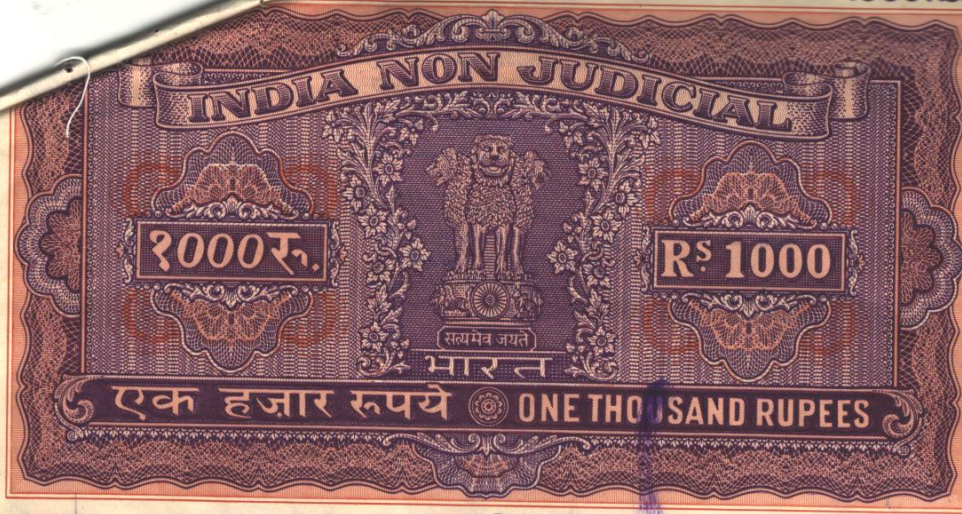

1. The name of the Trust shall be Prashanthi Seva Trust Bayar.
